**CURFEW ORDER**

I, **Te Berettenti, Taneti Maamau**, in exercise of the power conferred upon me under the Disaster Risk Management and Climate Change Act and the Public Health Infectious Disease Regulation, and following the conditions of Alert Level 3, hereby declare the following law for South Tarawa and Betio, Makin, Butaritari, Marakei, Abaiang, North Tarawa, Maiana, Aranuka and Abemama as follows: -

1. Curfew hours from 10pm to 5am everyday.
2. All Government Offices, SOES will continue to open for operation but to comply with the SOP in place for the offices. Church administration offices are encouraged to open for operation as they see fit and to comply with the SOP for offices.
3. All other private businesses are open but must adhere to the SOP for stores such as social distancing of 2m and compulsory wearing of face mask inside and outside of their shops at all times. Businesses must close at 9pm so that workers can reach their homes before 10pm.
4. Restaurants can open for takeaways ONLY but to comply with MHMS guidelines of social distancing of 2m, wear face mask, no spitting and nose blowing.
5. Fishing from 5am to 10pm is hereby allowed. All fishing boats are not allowed to visit other villages or islands apart from their point of origin.
6. Public transportation services may operate but will also observe compulsory face mask, open windows, no spitting and nose blowing and other MHMS guidelines and passengers must not share seats nor stand.

7. School closure will remain until Term 2, except for the islands of Kiritimati, Tabuaeran and Teraina which have limited access to internet and radio to participate in remote learning.
8. All kava bars, liquor bars, and night clubs will be closed. Bingo game is still not allowed.
9. Church services will be allowed and exempted for Easter Holidays commencing on Sunday 10<sup>th</sup> April and ending on Sunday 17<sup>th</sup> of April 2022 for worship only. Wearing of masks is mandatory during worships.
10. Parliament meeting is allowed and will follow SOPs such as mandatory wearing of masks.
11. Any other social gatherings up to 50 people are allowed to gather in outdoor setting. With appropriate distancing, masks and good ventilation.
12. Access to hospital services will be conducted according to the Ministry of Health and Medical Service guidelines as earlier announced.
13. Delivery of cargoes, fuels and medical supplies by vessel or air service will continue to outer island.
14. Travels to outer islands that are COVID-free is now allowed following SOP, i.e. tested before travel, self-quarantine, tested negative before travelling, and 3 days quarantine on the island and tested negative before release. Island Councils are responsible to make preparations for designated quarantine centre on their islands.
15. During the travel passengers and crews must also observe mandatory wearing of face mask. Vessel operators must ensure that this requirement is followed. Other SOP requirement in relation to travelling must also be followed by the passengers and crews.
16. All police officers and other responsible Government officers are hereby ordered to ensure that this Order and future directions issued out of this Order and Public Health (Infectious Disease) Regulation and the Disaster Risk Management and Climate Change Act are complied with by the public.

17. Urgent direction(s) other than those listed here, if there is a need, may be issued later to the police and other officers of the Government for execution in relation to certain areas or groups of people or activities etc where it deemed necessary to achieve the purposes of this Order and the Public Health (Infectious Disease) Regulation and the Disaster Risk Management and Climate Change Act in relation to COVID-19.
18. Any person who contravenes any conditions of this Order commits an offence and will be liable to be arrested by the police or imprisonment. On the spot fines of \$100 may be imposed by enforcement officers and such fine must be paid to the Ministry of Finance within 14 days from the date of issue or face prosecution. For clarification purposes, any breach of all the provisions of the Public Health (Infectious Disease) Regulation is an offence.
19. In case of any inconsistencies between this version and the Kiribati version, the Kiribati version shall prevail.
20. This Order repeals any previous Lockdown and Curfew Orders and is effective from 6<sup>th</sup> April 5 am until 29<sup>th</sup> April 2022 at 5am.
