**1. Short title**

This Act may be cited as the Supplementary Appropriation (No.1) Act 2026.

**2. Authorisation of issue of \$8,502,854.00 from the Consolidated Fund**

The issue from the Consolidated Fund is hereby authorized of a sum of **\$8,502,854.00** to be applied for recurrent expenditure to the service of the year ending 31 December 2026.

### 3. Appropriation

The sum specified in section 2 shall be appropriated for the supply of the Heads of Expenditure specified in Column 1 of the Schedule annexed to this Act in the sums respectively specified in relation thereto in Column 2 of the Schedule
