**AN ACT TO AMEND THE SALARIES AND ALLOWANCES OF MEMBERS OF
THE MANEABA NI MAUNGATABU AND SALARIES TRIBUNAL**

Commencement:
2026

MADE by the Maneaba ni Maungatabu and assented to by the Beretitenti

Short title and commencement

1. This Act may be cited as the Salaries and Allowances of Members of the Maneaba ni Maungatabu and Salaries Tribunal (Amendment) Act 2026 and shall come into force on such date as the Beretitenti may by notice published in the Gazette, appoint.

Amendment of section 4

2. Section 4(7) (a)(ii) is amended by deleting the words “reciepted iuncidental of” appearing before “not”

3. Section 4(7)(a)(iii) is amended by deleting the words “a receipted incidental follows the lists of payments made” appearing between “section” and “to” and substituting in the words “payments are made”.
4. Section 4(7)(b) is amended by deleting the words “TUC and BTC” appearing between “from” and “and” and substituting “Tarawa Teinainano and Betio”
5. Section 4(7)(c) is amended by : -
 - (a) deleting the words “receipted incidental as the Beretitenti and Minister when he/she returns to his/her constituency after the Parliament sittings in the” appearing between the word “same” and “amount” with no substitution; and
 - (b) deleting the words “their consultation” appearing the words “for” and “for” and substituting in the words “his/her constituency *kaongora*”

EXPLANATORY MEMORANDUM

1. The deletions are to sub-section 7((a)(ii), (iii), (b) and (c) of Section 4—"Travelling allowances and privileges."
2. For the information of this august Maneaba, the targeted performance of the deletions is to enable the MM (Member of the Maneaba) to claim his/her "Constituency Allowance" very similar to that of claiming other allowances that are governed under the Salaries and Allowances Act for MM, that is claims for such allowances are not accompanied by "receipts", and also to educate our people especially those who will read section 4(b) that the MM from the 2 sectors of Tarawa Island are not representing the Councils of Tarawa Urban and Betio Town. Such MMs represent the people of Tarawa Teinainano and Betio.
